On 03/09/25 via email to Sam Burns, it was noted that the CEMP and sub plans were close to being finalised with the exception of the CTMP and given the lengthy delays with agency reviews which is required for consultation, a request was made to submit a staged CEMP. This was accepted by DPHI on 04/09/25.
